

Frame Tender for the supply of Original spare parts for TERBERG equipment operated by Ashdod Port Company, such as TERMINAL TRACTORS and other equipment (the "Tender" and/or the "Frame Tender")

1. Pursuant to the Mandatory Tenders Law, 1992 and the Mandatory Tenders Regulations, 1993, Ashdod Port Company Ltd. (hereinafter referred to as "APC"), hereby invites proposals for the supply from time to time and on an as-needed basis of:

Original spare parts for TERBERG equipment operated by APC such as TERMINAL TRACTORS and other equipment, all as specified in the Tender documents including in the Frame Agreement attached hereto (hereinafter the "OTP") and as shall be defined in the purchase orders to be issued by APC from time to time.

2. APC wishes to sign with the selected proposers on Frame Agreements, as attached to the Tender documents, for the supply of OTP from time to time. For each purchase of OTP, APC will invite selected proposers to submit a quotation for the relevant OTP. Further details regarding the Purchasing Process which will be conducted from time to time by APC is specified in the IFP.
3. The Frame Agreements to be signed with the selected Proposers shall be for a period of 12 months as of signature. APC shall have the option (the "Option"), **at its sole discretion**, to extend the Framework Agreements for a period or accumulating periods of up to a total of four (4) additional years. APC shall be entitled to purchase the OTP underlying the Option on same terms and conditions, including, lead times for delivery, etc. of the initial year.
4. Pre-requisites
Proposers, who maintain **all conditions** as follows, will be entitled to participate in this Tender:
 - 4.1. Proposer undertakes to supply the **Original Spare Parts for TERBERG equipment** operated by APC such as **TERMINAL TRACTORS and other equipment as specified in the tender documents, and signed the** declaration attached to the IFP as attachment C; **and**
 - 4.2. Israeli dealers must maintain the following pre-requisite in addition to all other pre-requisites:
Proposer has submitted all certifications required according to the Public Corporations' Transactions Law, 1976 as specified in the IFP.
5. Proposals should be submitted not later than May 7, 2014 at 14:00 IL Time. Proposals should be submitted to the Tender Box, at the chamber of the head of Equipment Procurement Department, Equipment Department Building, 1st floor, Port of Ashdod.
6. APC is not obligated to accept the most inexpensive proposal or any other proposal. APC reserves the right to reject any or all Proposals and to re-advertise or to cancel the invitation for Proposals process.
7. APC reserves the right to negotiate with selected Proposers, *inter alia*, in order to receive "best and final" quotation for the OTP.
8. APC reserves the right to purchase the OTP from one or more Proposers, according to APC's consideration and needs.
