

**Tender for the supply of expert supervision Services with respect to the supply to APC of Pilot Boat (the "Tender")**  
**Tender No. 2581/YAM/15**

1. Pursuant to the Government Procurement Agreement (GPA), the Mandatory Tenders Law, 1992 and the Mandatory Tenders Regulations, Ashdod Port Company Ltd. ("APC") hereby invites proposals ("Proposals") for the provision of:

Expert supervision Services (as described in the IFP and in Section 2 to the Agreement) with respect to the supply to APC of one (1) Pilot Boat ("**Boat**") which is to be provided with training services, spare parts and warranty at Auxiliar Naval Del Principado, S.A site in Spain and in Israel, and delivered to APC at Ashdod Port, Israel, pursuant to an agreement signed between APC and Auxiliar Naval Del Principado (hereinafter referred to as "**Auxiliar**") as of March 18, 2015 (hereinafter referred to as the "**Principle Agreement**").

2. In connection with the aforesaid, APC will receive sealed competitive proposals ("Proposal(s)") from expert supervision companies (each shall be referred to as the "**Proposer**" and collectively as the "**Proposers**"), based upon the terms, covenants and provisions of the Proposal Documents as detailed hereinafter.
3. APC shall have the option, at its sole discretion, for a period of three (3) years from the date of APC's execution of the agreement with the selected Proposer, to receive from the selected Proposer additional Services with respect to the supply to APC of up to additional one (1) Boat.

Furthermore, APC shall have the option, at its sole discretion, to increase the extent of the Services up to twenty percent (20%) of the consideration according to the prices in Financial Proposal, and the Proposer commits to execute all of its obligations according to the Agreement terms.

4. Pre-requisites

Proposers who maintain **all conditions** as follows will be entitled to participate in this Tender:

- 4.1. Proposer is a company or a corporation, member of the IACS Classification Societies;  
**and**
  - 4.2. Proposer has supervised, during the years 2010 – 2014, the building of at least two (2) boats with length of at least fifteen (15) meters per boat, which were supplied and operated by customers; **and**
  - 4.3. Only with respect to Israeli Proposers:
    - 4.3.1. Submission of all certifications required according to the Public Corporations' Transactions Law, 1976 (תשל"ו-1976) (חוק עסקאות גופים ציבוריים); **and**
    - 4.3.2. The Proposer and/or its controlling shareholder and/or its employees that provide the Services to APC do not have any conflict of interest regarding the supply of the Services to APC.
  - 4.4. Proposer is not providing any classification services to the Supplier regarding the Boat.
